# Admissions Arrangements

**Review Frequency:** Arrangements to be determined annually. Any changes must be consulted on and where no changes are made, consultation is required at least every seven years.

**Approval:** Full governing body or a committee of the governing body where the school is an admissions authority

## **Policy Statement**

### **Introduction**

This statement sets out the legal framework, the definitions and our policy expectations.

The L.E.A.D. Academy Trust requires this policy to be implemented by all its member academies.

The 'admission authority' for all L.E.A.D. academies is the L.E.A.D. Academy Trust and the Trust therefore publishes the admissions policy for all its academies. The Trust follows local admission arrangements.

### **Appeals**

Any applicant refused a place at an academy has a right of appeal to an independent appeal panel established by the admission authority for that academy, i.e. the L.E.A.D. Academy Trust.
